GENERAL RENTAL RULES

- Rental deposit must be paid at the time of reservation. Without payment, there is no reservation.
- Rental Agreement Form must be signed and dated.
- Must give a 24-hour cancellation notice in order to receive a total refund of payment.
- Rental party is allowed to bring in food, but the food must remain in the concession area.
- Full rental payment must be paid before the party begins.
- The renter/rental party is responsible for any damages to the facility or facility equipment.
- If the weather is not up to normal operating standards, the renter will have the option to reschedule for a different date, or they will receive a refund for their payment.
 - Additionally, if mechanical issues were to occur with the facility, the renter would have the same options as above.
- PLEASE PACK UP AND PREPARE TO EXIT AT YOUR SCHEDULED TIME

AQUATIC CENTER RULES

- No one under the influence of a controlled substance may enter the pool.
- Use of controlled substances within the pool complex will subject that person to removal and/or police action.
- No flips off the side of the pool.
- No playing with poles, rescue tubes, or other lifesaving equipment.
- No playing around guard chairs.
- No lounge chairs in the water.
- No food is allowed outside the concession area.
- Use of any tobacco products will not be permitted anywhere in the facility or around the facility area.
- Rules will be amended when deemed advisable for the protection of health, safety, and enjoyment of all pool patrons.

NO RESERVATIONS WILL BE ACCEPTED FOR JULY 26, 27 OR 28

By signing this, I release any and all claims for liability which may arise. I understand that injuries may occur and that the City of Garner, Garner Parks and Recreation Department, Garner Aquatic Center, and any employees and volunteers are not responsible for these injuries whether through their negligence or otherwise. I further agree to waive and relinquish all claims I may have as a result of participating in this program/activity against the City of Garner, Garner Parks and Recreation Department, and Garner Aquatic Center, including their employees.
